02a – Updated Release 1 Indicative Project Timeline – April 2025



02a – Release 1 Project Status

- > AMO Readiness
 - Testing for the AMO Readiness milestone is progressing with testing priority on reference data integration
 - To mitigate potential testing delays and reduce resolution time, BaNCS reference data experts are on-site and an additional SME resource has been on-boarded
 - AMO Readiness testing is targeted to be completed by late-June 2025
 - Build for the AMO Security Details Report has commenced and is targeted to be completed by late–May 2025. Other key features to be delivered include the alternate file ingest interface to ITE and enhancements to support production message volumes.
 - BaNCS performance test on 20M trade messages per day is scheduled to be executed by late-March 2025.
 - ASX non-functional performance testing is expected to commence in late-March 2025.
- > Clearing Regression
 - Detailed analysis and test planning has commenced for the Clearing Regression milestone
 - From October 2025, Clearing Participants are expected to perform testing using a combination of ASX tooling to upload trades when testing in a controlled environment, or matching Trading Participant trades in an AMO test environment
 - AMOs and Clearing Participant's are anticipated to coexist in ITE without impacting each other's testing.



02a – Release 1 Project Status

- > Other Release 1 Updates
 - Internal training sessions for Operations staff on the BaNCS product are progressing. These sessions are supporting the planning for UAT, which is targeted to commence in May 2025.
 - Detailed planning for the upcoming internal Dress Rehearsal milestone is underway.
 - Internal Dress Rehearsals are expected to begin in July 2025, with external Dress Rehearsals expected to commence in November 2025.

02b – Release 2 Project Status

> Drop 1

- Completion of the Drop 1 business requirements is anticipated by late-March 2025 and sign-off by late-April 2025.
- Solution design work is also underway for the two new channels in scope for Drop 1, a new messaging channel (AMQP channel) to support ISO messaging and a new external user interface channel to support testing for software providers.
- > Drop 2
 - Pre-analysis for Drop 2 is progressing with completion targeted for late-April 2025.

- Some AMO / Software Providers testing on most business messages within AMO Build & Test apart from 'Password Changed'
- Industry reporting as per the next slide will start to incorporate monthly activity of messages, followed by progression metrics for key milestones and sentiment as volume increases

04a – Clearing Regression Overview – Release 1

In preparation for the Clearing Regression phase, ASX proposes to capture early feedback to develop the guide that is targeted to be published next quarter

Clearing Regression Phase

Between October 2025 and February 2026, Clearing Participants are required to perform internal testing and validation of all downstream EIS messages received that result from trade registration, clearing and netting services. This is a mandatory industry test phase where Clearing Participants and AMOs will be operating in the same test environment.

04a – Clearing Regression Phase Approach – Release 1

Clearing Regression Phase aims to validate EIS messages generated by current CHESS resulting from the new trade acceptance and clearing services are correctly processed by Clearing Participant systems, including downstream systems where relevant.



04a – Options to Complete Clearing Regression Activities – Release 1

Clearing Participants are accountable for Clearing Regression testing and their readiness but may engage their Software Providers to assist with their testing activities.

In circumstances, where the Clearing Participant (CP) is relying on a Software Provider to complete Clearing Regression testing, the CP is still accountable for the testing and their overall readiness:

- Clearing Participants will need to attest that their Software Provider has completed the Clearing Regression testing on their behalf and that they are satisfied with the results.
- Clearing Participants or the Software Provider will need to test from trade notification through to the completion of Batch Settlement.

04b – Business Design Working Group – Registries Focus Group

A Registries Working Group session was held on 14 March to deep dive on areas of change for Share Registries in Release 2

- > Business Update
 - ASX presented items under consideration in the current CHESS Roadmap. This omitted the ability to hold unquoted securities on a HIN, which is currently under consideration. These enhancements are being considered as part of the annual CHESS Roadmap refresh which is aimed to be published early in QI FY26 and provides a 3-year roadmap for the current system.
- > Registry / Issuer Setup in BaNCS
 - Registries were broadly supportive of the proposed data model, retaining the flexibility current CHESS and extending to support the future CHESS UI.
- > Registry Reporting
 - There were some concerns around the impacts of providing of notifications at an Issuer level rather than Security level. However, it was acknowledged this is necessary to support extended notifications to Registries for a zero holding
 - Concerns were raised in relation to the impacts of delayed account notifications in some scenarios
 - Registries highlighted the importance of the Movements To / From Registry in the HMVT report
 - Registries are open to exploring options for a pre-check validation of account details in relation to offers.
- > Foreign Restricted Securities
 - No concerns were raised in relation to the changes to Foreign Restricted Securities. This discussion will be continued with Participants in April.
- > Investor Data
 - No significant concerns raised in relation to Investor Data
 - Addition of a "Nominee" Ownership Type is under consideration
 - Additional special characters are not expected to be supported given the potential complexity and increased likelihood of mismatches.

 - Change in balance notifications (acmt.002)
 - Settlement Instructions (sese.023, sese.024, sese.025, sese.028 & sese.029).
- > Remaining workflows relating to Drop 1
 - Investor Details TFN/ABN Notifications (acmt.003 & acmt.006).
- > Drop 2 functionality prioritised for next Working Group
 - Clearing Uplift (including trade registration and netting)
 - Settlement Instruction Cancellation (including housekeeping).

Participant Identification



05 – Participant Identification – Summary

Background

- > CHESS Project anticipates continuing to use the UIC as the primary identifier (BP Id) for Participants and Issuers from Release 1 golive
- > UICs are used by ASX and Participant systems. Maintaining it in CHESS project reduces migration risk and impact to Participant systems
- > Proprietary identification codes are used in other BaNCS implementations
- > Not all Settlement Participants in CHESS have a registered BIC.

Feedback for Consideration

- > Participants receive bilateral settlement instructions via SWIFT (MT54x)
- > Counterparty identification is either BIC, proprietary or free format
- > Translation is required on relevant EIS messages, currently maintained by each Participant
- > Manual intervention is required where free text provided doesn't align with mapping
- > Lack of centralisation has created multiple BIC to one UIC scenarios.



05 – Participant Identification – Next Steps

Proposal (presented at the 5 February Technical Committee)

- > Mapping of UIC to BIC list can be created, relying on the information ASX receives from Participants
- > Consideration is anticipated on rules changes to ensure Participants provide information on a timely basis to ASX and ASX's obligation to maintain an accurate up-to-date document for Participants to utilise in their Business-As-Usual processing
 - As BICs are not an ASX identification, ASX is not responsible for the accuracy of the information, or any adverse outcomes as a result of using the BIC
- > Either a static document which would be referenced from ASX's website or a machine-readable file which could be downloaded and consumed by the Participants systems
- > Subject to further solution analysis and planning activities.

Next Steps

- > Closure of the open action (2025-02-01)
- > BIC identification to be incorporated into ISO messages to enable future capabilities.
- > ASX will continue to evaluate the proposal.

07 – Approach to Customisation

ASX seeks to align the CHESS Project system to the TCS BaNCS MI product where possible, in order to support upgradeability and the ability to leverage future platform capabilities.

However, customisations may be required for one of the following reasons:

- > To operate with existing systems or market conventions
- > To support operational, market and/or regulatory requirements
- > To support backward compatibility for a phased release.

Where customisation is required, there are three ways the TCS BaNCS MI product can be customised



Modifications to core components

New components that interact with the core components of the solution via APIs



07 – Customisation Considerations

When determining whether to customise or to align with the TCS BaNCS MI product, the following may be taken into consideration





Customisation has impacts across the Product Development Lifecycle including analysis, design and development, documentation, testing, technical debt, and code complexity. In particular, the latter two can have impact throughout the Product Operational Lifecycle including on maintainability and upgradeability, potentially increasing delivered risk.
